# **MINUTES**

# I. Call to Order, Quorum Confirmation.

Meeting was called to order at 2:00 p.m. by Dennis Carson, President. Quorum was confirmed by combined mail-in ballots and in-person attendance.

#### II. Introductions.

- · New Path is now installed.
- Next year the Reserve Study calls for replacement of the cardio equipment, card readers and steam generator. Replacements will be made on an as-needed basis.
- · The Board is looking into new card readers.

#### VII. Questions and Answers

- · Is there a solution to the exposed drip line issues?
  - Inspections have started.
- Is management following up on complaints regarding violations reported from block captains?
  - No, we do not have block captains. Any violation reported is physically checked by the community manager.
- Currently, residents are giving clubhouse fobs to friends in order that they can use the pool. Is this ok?
  - No, the policy states that the resident is to be with the guest when using any of the Bellasera facilities.
- If a property is turned back, is the bank responsible for paying the fees?
  - Yes.
- When are the bicycles going to be replaced in the fitness center?
  - Appetite for Fitness checks them quarterly and advises us if they are in need of being replaced or repaired.
- How is a person to respond to a violation letter if they are out of town and can't comply in the 10 days given?
  - o Call the community manager and let her know the timeframe in which it will be taken care of.
- · What is the status of the budget for the Social committee?
  - Dennis explained that the FY 2011 2012 budget does not include a line item for the Social Committee.
