- Modifications
  - o 2 applications for paint change were reviewed and approved
  - Discussion of and request to review the welcome pkg regarding sign off on reading the governing documents – LF to bring to Feb. meeting
  - Solar panel installation request H/O completed installation prior to committee approval, send \$100 fine letter to H/O for failure to get final approval. HOA cannot deny placement of solar panels, but does have other authority regarding panes colors, reflectivity etc.
