MANAGER ACTION ITEMS:

- Attended the Building and Grounds Committee meeting on December 8th.
- Attending the Budget and Finance Committee meeting on December 18th.
- The revised Facilities Policy and Violation Policy has been mailed to all residents.
- Richard Hoffman, Guy Yates, Bruce Martin and I met with Tyler Ware for a punch list walk on December 14th. The erosion corrections are complete and acceptable. Cactus Paving will be returning to do additional crack sealing.
- The handicapped shower in the men's restroom cracked and is leaking to the outside of the building. We were asked to obtain two more proposals on this issue. We contacted Arizona Consolidated Services and Rainforest Plumbing. ACS gave a proposal for \$600 and it was accepted. When he came out to do the repair he was able to find a part required and the cost went down to \$400.
- The proposal from Steel Creations for installation of additional railings has been accepted.
- The trail markers and decals have been installed by a group of volunteers.
- All Brite Pool Service is very responsive when called for an issue. He has also furnished a proposal to replace the missing white tiles and deck joint repair for areas where the grout is missing. This issue is at the entrance to the pool. The proposal has been accepted.
