• Richard met with neighboring community Sincuinados (other side of our mountain) President regarding their information that the Wallace Garden Trust (who granted us an easement to cross the Trust's property on the mountain for our Lone Mountain Trail) has expressed an interest to sell their 20-acre parcel on Lone Mountain. Wallace Garden Trust had asked the Sincuinados to purchase the Property, which is subject to a Conservation Easement, for \$1.4 Million. They have no interest in a purchase but wanted us to cooperate with them to resist any effort to deny access to adjoining Sincuinados and Bellasera. We indicated no interest to purchase but would support their efforts.

- Proposal from Omega Construction to re-seal grout in steam rooms was deferred to Richard Hoffman for approval; however, approval was not given for the showers.
- Proposal's to replace pool furniture cushions and re-powder coat the furniture. Defer to next meeting. Dave Reid to get pricing from his vendor.
- AAA Landscaping proposals
 - Repair of drainage erosion are to the left of the clubhouse Approved
 - Repair of side retention basin facing Scottsdale Rd Not Approved
 - H/O request to assist with erosion at exterior wall Tabled to next meeting, invite homeowner to attend October Building and Grounds meeting
 - Remove Palo Verde at entrance Approved
 - Remove dead Ironwood behind guardhouse Approved with stipulation that Saguaro will not be damaged
 - Interior areas Not Approved
 - Remove Palo Verde at NWC of PonteBella & 74th way Tabled for further research
 - Replacement of sidewalk panels Not Approved, will grind sidewalk lips if necessary.
