Communications Committee Meeting

November 12, 2014

- 1. Previous meeting minutes not available. Will be emailed later.
- 2. Report on condition and plans for bulletin boards: a request has been made to replace cork matting and this will require an estimate of cost. There is talk of replacing the entire bulletin board system.
- 3. Modifications Committee has a new member and chairperson. His name if Kirk Rimsnider. In future there will be a change in reporting modifications to properties. There are privacy issues with contractors. Roads: In a condition report given by contractors, Bellasera's roads were described as having good integrity and care. A suggestion was made to improve handling of traffic load by removing three inches off top and recovering the roads leading to the "T" intersection. This action would cost about \$120,000 and should last some 25-30 years.
- 4. Modification discussion of information needed by Mod Committee to consider changes requested by residents. Currently change request and lot number is required; ultimately, in some instances, requesting resident does not know if approval is given. Question: how many people in community really care about requests and approvals, and is there a need for privacy information made public. Craig will pursue matter with the Board.
- 5. Oct. 25th cleanup day: cleanup day project took about two hours, used ten bags. There were four participants but group can grow to as many as eight. Blank forms to be signed should be brought to the site. City provides the pickers.
- 6. Newsletter: December issue will be a little different by including photos of gate and office personnel.
- 7. Website: Nothing new, but more challenges.
- 8. Next meeting will be held January 14, 2015 at 8:30 a.m.
