## **Compliance With Governing Documents**

A comment by one of our residents at our recent Board meeting caused me to provide an overview of the process we must go through by law to encourage compliance with our Governing Documents (primarily the CC&Rs and Design Guidelines). The Chairman of our Communications Committee suggested I repeat some of my comments in this column.

While the Board, our Community Manager, and some of our residents can become frustrated at the length of time a violation continues, many violations are resolved with our first Courtesy Notice. However, if a resident disagrees with the violation or simply decides not to comply, the process can be strung out for a lengthy period of time. The law gives a resident 10 days after the initial notice to respond. After receipt of the response, the Association has ten days to provide a written explanation of the violation and other information, including what the resident must do to contest the notice. The resident then has the right to petition for a hearing, which is set by the Board. In many cases, the Association doesn't receive a response to the Courtesy Notice and will then send out a second letter imposing a fine for the uncorrected violation. In some cases, we still don't receive a response. The third notice imposes a second fine and we usually hear back at this point. In some cases, the resident is either traveling or is not a permanent resident and for various reasons hasn't received the notices. When we finally hear from them, we do our best to work with them on getting the violation resolved. I should mention here that if the property is in bankruptcy or foreclosure, a whole new set of problems and delays crop up.

Our primary mission in enforcing the Governing Documents is to gain compliance on a voluntary basis. It is not to punish our residents in a heavy-handed manner. However, when it is clear a resident is aware of the violation and still refuses to comply, it is sometimes necessary to impose fines to gain enforcement.

The Association has the option of attempting to resolve the matter itself and billing the resident or filing a lawsuit. Both of these approaches are potentially costly and very contentious. So far, the Association has not had to resort to these approaches to gain compliance. I hope we never will!

Watch for suspicious persons or activity and report them immediately to the Scottsdale Police Department, **480-312-5000**.

Residents are encouraged to ensure all outside lights are working, and when you're away from home, leave a light on. Check to make sure your home intrusion alarm is working to your preference.

Bellasera resident **Mike Simpson**, a recent victim of one of these crimes, has provided lessons learned from his experience:

- 1) Even though the house alarm was armed, no windows or doors were opened. The burglars broke the sliding glass door in the bedroom, then entered and exited through the shattered portion of the door. There is a motion detector on his system, however it is located in the family room. Lesson 1: if you have a system, install a motion detector in every room that has items of value -- specifically the master bedroom.
- 2) Lesson 2: Move your jewelry. The burglars went right for the bed stand, the closet drawers, dressing area drawers, and then left. They were not apparently interested in electronics or anything else. They wanted to stay light and not have to carry any large items. As with most others, the jewelry was stored in predictable places.
- 3) Lesson 3: If you happen to have a gun next to your bed, you have armed your burglar. It was probably the first set of drawers they opened in Mike's home.



## **January in the Garden**

#### **Shrubs**

As we celebrate New Years, January is a good month to take a critical look at your garden, especially the utilization of shrubs. If you are new to our beautiful community or are planning a new area in your garden, think about the shrubs that you have or might want to plant. Shrubs are normally permanent parts of

a garden and, except for trees, are the largest plants that you will invest in. Like trees, they set the tone and style in the space in which they are planted. To help you decide which shrubs to choose, the following questions should be considered.

#### 1. Do you want the shrubs to hide anything?

If yes, be sure that they are large enough to screen whatever it is that needs to be hidden. To judge how large a shrub needs to be to hide something outside the yard, like a neighbor's window or a terrible view, take a long stick or pole and hold it up in the area where you intend to plant the shrub. It will give you an idea of how tall your shrub needs to be or grow to accomplish its job.

#### 2. Do you want it to bloom at a particular time of year?

Many shrubs are wonderful flowering plants as their blooms become the highlights of a garden. If a shrub is especially colorful, consider planting it where it will be seen, either up close or as part of a view. Have a large shrub rise up over a large boulder, wall, bench or other substructure so that it appears to peek and invite you to go see it.

#### 3. Do you want to use shrubs to define space in the garden?

One of the ways to make a small space look larger is to create visual barriers that prevent you from seeing it all at once. These are sometimes called garden rooms. Other, simpler applications could be just a matter of making you walk around a shrub to get to the side yard or putting a dense layer of shrubs behind the patio so that you have to walk around them to see what is behind them.

#### 4. Are the choices you made compatible with all the rest of your garden or your area?

Give some thought to the exterior of your home and the style of your yard and garden. Nothing looks more ridiculous than immense towering shrubs over a small house and yard or tiny neat shrubs lining the driveway of a naturalistic yard.

Finally, choose plants that are adaptable to our desert environment. Ensure that they do not require excessive amounts of water when they mature and have sufficient heat and cold tolerance for our area.
