# **Election, Legislation, Enforcement**

I urge everyone to return your mail-in ballot for the Annual Meeting if you do not plan to attend in person. Even if you choose not to vote for any Director candidate, your returned ballot counts for purposes of determining a quorum. If we do not get the requisite number of attendees and returned ballots, the Annual Meeting will need to be rescheduled. Also, please note that the ballot lists four candidates for four open board positions. Due to a timing question with the submission of his application, and the desire to avoid any appearance of impropriety, **Bruce Martin** has withdrawn his name from consideration.

Last month I commented about members' responsibilities under the CC&Rs when leasing residences. I noted that our CC&Rs require a minimal rental term of at least 30 days. Since then I have become aware of proposed legislation in the Arizona legislature addressing lease terms for planned communities. If the legislation becomes law, planned communities will not be able to regulate the minimum time a unit can be rented. If you believe our community might be adversely affected by enactment of the proposed legislation, then I urge you to contact your state representative and let your position be known. Send me an email if you would like to receive a link to the proposals.

On another note, the Board has a fiduciary duty to all members to follow and enforce the CC&Rs. Unfortunately, at times this puts Board members at odds with some members of the community and makes life unpleasant for both sides of the issue. An example might be where a homeowner is in violation of unauthorized art in their yard. The preferred solution is for the Association to write a letter in a respectful tone, which brings an issue to the attention of the member and results in immediate corrective action to the satisfaction of both sides. Sometimes that just doesn't work and the Association's only alternative is to levy a fine. Members can then follow a required appeal procedure. The Association has historically kept CC&R violations confidential, and they are not published or discussed publicly at Board meetings. Whether that practice is mandatory depends on the interpretation of Arizona law. Arizona law, section 33-1804, requires all Board meetings be open. The section specifically enumerates certain topics excepted from the open meeting requirement, which a Board "may" reserve for executive session. The word "may" is important. Another interpretation might be that violation notices are not even topics that fall within the exception. My preference is to continue to interpret the law to maintain these Board discussions confidential and deal with violations discretely. Alternatively, a more aggressive approach may result in better compliance. Anyone wishing to voice an opinion on this topic is welcome to write a guest column for the newsletter.

# **Management Report**

### MAJOR ITEMS COMPLETED SINCE LAST MEETING:

- Approved and coded invoices for AP processing.
- Reviewed January and February financials and prepared MTD/YTD variance reports.
- Additional items shown on the Community Fix-up List prepared by the Building and Grounds Committee
  have been completed. Specifically, the wall at 77th way is being repaired and painted as well as several
  other walls within the community. The sidewalk on Corva has been completed. Electrical wires were buried at the entrance and at the back gates.
- I met with Blue Estrada of Shasta and the members of the resurfacing crew February 8th. At that time the area that continues to crack at the beginning of the beach entry was discussed. The remedy is to install non-skid 1 " x 1" white tile which would eliminate the cracking in the cement walls. A proposal has been accepted to have this work completed.
- A proposal has been requested for glass beading of the tile along the waterline.
- As you are aware, Shasta has begun the work to resurface the pool and spa.
- Arrangements were made with Terravita for our homeowners to use their pool during the resurfacing of the Association's pool.
- GB Maintenance has completed the caulking on the gutters around the clubhouse.
- GB Maintenance has painted the kitchen ceiling and touched up on the water stain in the ladies locker room.
- Another proposal was received for the painting the exterior of the club house and again did not receive spec sheets.
- I have contacted GB Maintenance for correction of the citation received from Maricopa County Environmental Services regarding the masonry columns around the pool that create a foothold issue.
- I have the proposals for the pool furniture; however, have not had the opportunity to compare them.
- Sharon contacted the Scottsdale Fire Department for CPR and defibrillator training that was held on March 16th.
- I met with the Budget and Finance Committee two times to prepare the preliminary budget for the upcoming fiscal year.
- Sharon and I continue to field telephone calls and e-mails.
- Heidi Dalhof, Community Manager, completed an inspection tour for me.

# April in the Garden

Even with all our winter rain, there are some items in your garden that require special consideration when watering. Yes, it will get warm and the winter rains will no longer be with us. And, with spring around the corner, let's think **Butterflies!!** 

### **Succulents**

Watering succulents on an automated watering system presents a challenge since the amount and frequency of watering for herbaceous and woody plants is lethal to most succulents. Hence, succulents should not be on the on the same line as trees, shrubs, perennials, or lawns and you should consider:

- 1. Dedicating one station entirely to them or, if this is not practical,
- 2. Using adjustable emitters for your succulents to enable you to manually control the intervals.

### **Shrubs**

How large a shrub becomes is generally determined by how much *water* and *fertilizer* you give it. Once a shrub reaches an optimum size (for you), significantly reduce your fertilizer application. Fertilizer is added to promote growth, and, if you no longer need a plant to grow quickly, slow it down. The same is true of water. One of the advantages of well-adapted plants in any region is that when mature, they need little supplemental irrigation beyond what is provided naturally. Take advantage of this trait, and water shrubs only enough to keep them healthy once they reach full size.

### **Citrus Trees**

Any remaining fruit on your citrus trees will often drop this month because of high winds and increasing heat which is normal. You need to continue with their regular watering schedule and clean up the dropped fruit. Leaving it to rot encourages insects and disease around the plant.

### Ocotillo: Dead or Alive?

With all of our rain, ocotillos have mostly appeared to be lush and green this winter. If yours has continued to be an arrangement of large dead sticks, do not assume this curious, unique plant is dead. Here are a couple of ways to find out:

- 1. Take the end of the cane and pull it gently toward the ground. If it bends it is still alive.
- 2. Look carefully at the stem around the thorn. Surrounding the thorn is a diamond-shaped area that often has tan or whitish bark that peels away. Beneath that bark the stem should be green or yellow green. If it is dark gray, the cane is dead.

Always prune canes as far back as you can to prevent unsightly stumps and spindly branching.

### **Butterflies**

If you have ever been to the magnificent Spring Butterfly Exhibition at the Desert Botanical Garden in Phoenix, you might be encouraged to attract butterflies to your garden. To accomplish this, you will need to grow perennials that are in bloom and full of nectar when most butterflies are active in summer. Plants in the verbena family are renowned butterfly attracters as well as lantana. To get started:

- 1. Plant a generous number of verbenas of any type, Moss and Gooding's are a good start.
- 2. Add a number of different colored lantanas. The colors do not matter, so go with varieties that are compatible with your garden.
