2014 Annual Meeting Review

The 2014 Annual Meeting of the Bellasera Community Association was held on Sunday, April 13 at 2:00 p.m. at the Bellasera clubhouse. A quorum was established by more than 160 mail-in ballots and we thank the many residents who attended in person. The three candidates for open Board positions, **Richard Hoffman**, **Craig Johnson** and **David Reid** were elected to new two-year terms. At the Board meeting following the Annual Meeting, the following Officers were elected: **Richard Hoffman** – President; **Gregg Dittoe** – Vice President; **David Reid** – Treasurer; **Dennis Corbett** – Secretary.

Gregg Dittoe – Treasurer – gave a short presentation with respect to the Association's finances. The financial state of the Association is excellent and the Budget for the upcoming fiscal year was discussed. Results for the past fiscal year were 1% over budget with administrative, repairs/maintenance and insurance costs slightly over budget and utilities costs under budget. Accounts Receivable are now close to zero and for the first time since the beginning of the financial crisis in 2008, nearly all 360 homes are current on their quarterly assessments. The Owner's Equity Reserve (essentially our "Rainy Day Fund") stands at more than \$51,000. To maintain a balanced budget, a \$15 per quarter increase in Association Dues was recommended by the Budget & Finance Committee – an increase of less than 2.8% over last year. Since 2009 the Association dues have increased by 6.7% overall, or approximately 1.1% per year. The new Board approved and adopted the proposed Budget at the Board meeting following the Annual Meeting. The increase will be effective beginning with dues starting July 1. We thank the members of the Budget & Finance Committee and our Community Manager, AAM, for their on-going efforts in monitoring the finances of the Association, including our Reserves, which now total over \$1.074 million. This places us at 73% reserved against scheduled and projected capital expenditures – which equates with an "excellent" rating for similar homeowner associations.

Richard Hoffman – President - reported the View Fence painting program was almost complete and that very few homeowners chose to "opt-out" from participating. Special thanks were expressed to **Dennis Corbett** in managing the day-to-day details of the effort, and to **Keith Christian** and the Communications Committee for their coordinated e-mail blasts to homeowners affected on a week-by-week basis as well as posting addresses of the affected residences at the mailboxes prior to the painters scheduled arrival for each coming week. The overwhelming cooperation and patience of our residents is sincerely appreciated.

The biggest accomplishment this past year was the recent Settlement of the Easement Litigation with the owners of the adjacent 12-acre tract. An e-mail blast was sent to Bellasera homeowners the week of April 7 describing the basic terms and details of the settlement. Our counsel, **Jason Smith** and **Lindsey Stearns** of the Carpenter Hazelwood Law Firm, attended the Annual Meeting and answered questions from the residents in attendance on the status of the Settlement ("99% finished") and the terms of access agreed to by the Board on behalf of the Association.

Upcoming Projects –

Lone Mountain Trail - We have hired a contractor to construct the new trail and are working through our legal counsel to finalize the terms of our construction and use easement across the Wallace Trust property to connect to the existing trail on Lone Mountain. We expect this to be finalized shortly. The timing of actual construction is dependent on our contractor's schedule, availability, and weather considerations. Construction will likely begin sometime in the fall.

New Workout Equipment for Clubhouse – The new Board will also be looking at updating our existing treadmills with new equipment and perhaps adding an additional elliptical machine. We currently have funds in the Reserve Accounts identified for this purpose and will be speaking with residents and our equipment supplier to determine our best options and choices.

Settlement Of Easement Litigation Finalized, But...

On Monday, April 21 the Settlement Agreement with the owners of the adjacent 12-acre parcel was finalized and executed between the parties. As part of the Settlement, a Joint Stipulation to Dismiss the existing Lawsuit was filed with the Court by counsel for the Plaintiffs and the Association, and an Access and Utility Easement and Deed Restriction (the "Easement and Deed Restriction") was filed and recorded with the Maricopa County Recorder. The Easement and Deed Restriction sets out the terms of access by the owners of the adjacent 12-acre parcel through Bellasera and the restrictions upon their further development of the 12-acres. A copy of the recorded Easement and Deed Restriction is posted on the Bellasera website, **azbellasera.org**. Click on "Adjacent Property Easement."

One of our homeowners who objected to the terms of the Settlement has hired legal counsel and is seeking to undo the Settlement and has filed a Motion with the Court to re-open the litigation. The ultimate decision will rest with the Judge in our case. We expect the Court to rule shortly. The Board strongly believes the Settlement is in the best interest of the Association members and will keep you updated on Court's final decision.

Bellasera in the Rear View Mirror

A look back in Bellasera history that may bring back memories for long-time residents and be of interest to those not living in our community in prior years. <u>Clips</u> from past newsletters follow.

Bellasera Neighborhood News, May 2004, 10 years ago

- Bellasera homeowners will be permitted to install re-tractable awnings under a change in the community's Landscape and Architectural Design Guidelines approved by the Modifications committee. There are a number of restrictions and requirements, however. These include prior approval by the Modifications committee. Prior to the change, awnings were not allowed.
- Bellasera's second Creative Hands arts show and sale was a success, its organizer, Janet Biondo, reported.
 The participating artists restricted to Bellasera residents— have already begun preparing for another show in the fall. "Everyone who came to the show on April 24 was amazed at the quality and diversity of the fine arts and crafts for sale," Janet said. "We're all ready to do it again and look forward to seeing you there."
- Dick Chenault held onto his position as president of Bellasera's homeowner's association. The board's two new directors and current director Robert Tack attempted to vote Chenault out of the position. The three directors, at the reorganization meeting of the board on April 26, fell one vote short of forcing a vacancy in the presidency as Chenault and director Al Ricciardi voted against Jim Gleason's motion to deny renewal of Chenault's role as president. According to Bellasera's bylaws, officers' terms automatically renew unless at least two thirds of the directors vote not to renew the term. With Bellasera's five-person board, four votes would be necessary. Meanwhile, Tack gave up his post as treasurer and new director Paul Agranoff was elected to the position. There were 128 homeowners represented at the April 8 annual meeting. A quorum of 108 was required.

Bellasera Neighborhood News, May 2009, 5 years ago

- On a beautiful spring Saturday morning, April 25, a large number of Bellasera residents gathered outside the clubhouse for the association's Annual Meeting. Board President Chuck Roach introduced the Board members, and recognized committee members attending the gathering. Following approval of the 2008 Annual Meeting minutes, Board Treasurer Dennis Noone provided a financial review, and reported that the quarterly dues for members will increase for the new fiscal year beginning in July to \$520.00 (now \$502.74). The results of the election were announced. Declared candidate Dennis Carson, along with write-in candidates Anna Ingram and Ted Dixon were elected to two-year terms on the Board of Directors.
- Bellasera has purchased a new tennis ball machine that is now available for resident use. Please check with the guard to sign out the key if you desire to use it.
- Monday, May 25 the Social committee is hosting a bar-b-q event, 4 p.m. In lieu of a potluck, we are requesting a \$10 per person reservation. Payments to be received at the event. We will also be honoring those who served and are serving in our armed forces. We look forward to seeing you!

May in the Garden

Getting Ready For Summer!

May is our transition month into summer as we will likely see the first day over 100°F while most days will be clear, dry and hot. This is an important month in that you need to pay attention to some *maintenance/upkeep* tasks which I've listed below. Of course, there is still an open window for some *selective planting* which I'll also cover.

Maintenance

Trees- May is a good time to pay some attention to your trees. Specifically:

--Pruning- Lightly prune desert legumes (like palo verde or mesquite) removing dead limbs and small crossing branches. Delay hard-pruning until later in the summer as it will encourage a heavy regrowth which will make them unstable and prone to toppling over during monsoon season.

- --Stakes- If you added stakes to trees that you planted in the fall, it is time to take them away. Expect the tree to lean at first, especially if it is small, but, as it gains strength, it will correct itself quickly
- --Watering- Increase the watering of newly planted or young trees to maintain a watering depth of 3 feet. This may mean watering once a week if the temperatures are already hot or if the soil drains quickly.

Drip System- Inspect your drip watering system for the coming summer heat.

- --Check your drippers to see if any popped out now that heat is making the hoses softer.
- --Water in the mornings, not during the heat of the day, or evenings and ensure that you are watering long enough to get to the thirsty roots. Irrigation should run the same length of time throughout the year to soak through the root zone; it is the frequency that changes seasonally.

Citrus- If you did not do so last month, fertilize trees with their second feeding of the year.

Do not prune citrus except to remove dead or damaged wood and branches obstructing pathways, views, or structures.

Lawns- If you have a lawn (there are very few in Bellasera), plant Bermuda grass when soil warms up in mid to late May.

Refresh Mulch- Before the heat hits, spread several inches of mulch on top of garden beds and around landscape plants. Mulch reduces soil temperatures, maintains soil moisture and inhibits weeds. Organic mulches, such as compost or bark chips, add nutrients to the soil as they decompose over time. Keep mulch several inches away from the stems and trunks of plants. Wet mulch touching plant tissue may encourage pest and disease problems.

What To Plant

Warm-Season Vegetables- A variety can be sowed from seeds including cantaloupe, okra, black-eyed peas, Tran Armenian cucumbers, and yard long beans. You can also transplant sweet potatoes and Jerusalem artichokes. **Note**: Okra is in the same family as hibiscus and hollyhock and tall-growing okra (3-6 feet tall) produces large lobed leaves and hibiscus-like flowers, which add beauty to summer vegetable gardens.

Succulents- In addition to flowers, May through the summer is the perfect time to plant warm season succulents. Remember, many plant families make up the succulent species, the best known being cactus. Virtually all cacti (or cactuses) are succulents, but many succulents are not cactus. **Note**: Next month I'll give you some general planting and maintenance guidelines for succulents as well as some specific advice on Cactus, Aloes and container grown Agaves.

Citrus Tree – Have you seen the price of lemons and limes lately? Consider planting a *miniature* lemon or lime tree (in your back-yard of course). May is an excellent month to add any desert adapted or native tree.

Miscellaneous

Roses- Continue fertilizing established roses, liquid fertilizers can be added at 2 week intervals, follow the directions on the container.

Herbs- Maximize the flavors and aromas of herbs by harvesting them in the early-morning hours, after dew has evaporated but before the sun heats up.

Don't worry- It is very common in May and June to see half-moon cutouts on the leaves of bougainvillea, roses and other smooth foliage. *Female leafcutter bees* neatly cut away a piece of foliage, carrying it off to line a nest. Leafcutter bees are solitary creatures and not interested in stinging humans; so there is no need to worry about them forming a swarm. They neither harm plants nor ingest foliage, thus insecticides are unnecessary. If you grow show roses, prevent aesthetic damage by using floating row covers over shrubs.

What attracts Humming Birds? Next month I'll give you some details on when and what attracts these beautiful creatures to your garden.
